The Executive Council is a combination of the General Council Executive Board, the president of each standing board of General Council, the president of each State Council, and two additional members from Ohio. Other individuals will be invited to join in this important conference as guests even though they would not be official members of Executive Council.

The Executive Council is not legislative; in other words they have no power as a group other than what each individual board and council represented would have separately. The purpose of the meeting is to receive specific reports regarding the ministry of the Gospel - within local churches, the communities they serve, and in the church's outreach to the world.

Beyond hearing reports, Executive Council will place a major emphasis on coordinating plans and making recommendations to allocate our resources of time, energy and finances to help local churches become authentic and healthy; churches where people who are far from God are finding life and hope. The discussion, Bible study and prayer will be centered on applying Biblical principles in practical ways to help churches.
